Sealed quotations/Tender are invited from interested reputed Travel Agencies/Tour Operators or Private individual for providing 1(One number) of Non-AC Indica / Bolero-diesel driven vehicle having sitting capacity not more than ten including drivers, which shall confirm to the Terms and condition(Annexure-II) for official use in District Employment Exchange, Bargarh on daily / monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 (Three) years old from the date of initial registration and must have valid Registration Certificate, Fitness Certificate, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the Vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. The monthly/daily rate of hire charge be quoted separately in the general bid information(excluding fuel and lubricants)
5. The vehicle must achieve a fuel efficiency of 14 Kms per litre.
6. The detail of the make and year of manufacture of the vehicle, registration Number, mileage (Kms covered per litre) and name of the Driver with Driving License Number and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender (Annexure-III).
7. The Quotation completed in all respect should reach the undersigned on or before 23.06.2018 within 5.00 pm and shall be opened in presence of the bidders or their authorised representatives.
8. The application form of quotation/tender containing general bid information & term and conditions for hiring of vehicles etc will be available with the office of the District Employment Officer, Bargarh from 06.06.2018 to 22.06.2018.
9. The vehicle shall not be more than 3(Three) years old from the initial registration and also in good running condition during the period of contract.
10. If the vehicle is found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. This quotation is valid for the financial year 2018-19.
13. The undersigned has every right to cancel the quotation without assigning an reason thereof.
