In pursuance of Letter No.7467/Elec. Dated 05.09.2018 of Chief Electoral Officer & Ex-Officio Principal Secretary to Government, Home (Elections) Department, Odisha, Bhubaneswar Sealed tender in plain paper are invited from the local bonafide Suppliers /Manufactures /Agency/Firms/Co-operatives for preparation of Flex Banners (Size-5ft x 4ft each & Quality- 300 GSM Star Flex) for Systematic Voter's Education and Electoral Participation (SVEEP) materials relating to ongoing Special Summary Revision Programme 2019 .The details of the article is enclosed herewith. The sealed tender paper should be dropped into the Tender box meant for the purpose kept in the office chamber of the District Election Officer, Bargarh by 3.00 P.M. of Dt.11.09.2018 during the office hours which will be opened on the same day i.e. on 11.09.2018 at 5.00 PM in the office chamber of the Collector and District Election Officer, Bargarh in presence of the members of Tender Evaluation Committee and the tenderers or their authorized representatives. Tenders received after the stipulated time shall not be accepted.

1. Each tenderer is required to deposit earnest money of Rs 5,000/- (Rupees five thousand) only in shape of demand draft payable to District Election Officer, Bargarh at the Main Branch of State Bank of India, Bargarh. Tenders without earnest money deposit will be summarily rejected .The earnest money of the unsuccessful bidders will be refunded on the day of finalization of the tender.

Up to date GST / Income Tax clearance should be furnished along with tender papers without which the tender will not be taken into consideration.

2. The tender should be accompanied by samples of the articles to be supplied which should be furnished in separate packets super scribed "Sample of the article and name of the party and to be produced before the Tender Evaluation Committee on Dt.11.09.2018 at 5.00 PM.
3. The intending tenderer may ascertain the specification of the articles from the list enclosed.
4. The tenderer will be required to supply the article within seven days from the date of receipt of the supply orders.
5. The earnest money will be released only after satisfactory performance of supply.
6. In case of failure to supply the article of required quantity in full with specification within the stipulated period the security deposit of the tenders will be forfeited.
7. The price quoted in the tender will include all tax, transportation charges. The delivery of articles of all the materials will be made in the District Election Office, Bargarh.

The Collector & District Election Officer, Bargarh reserves the right to reject any/all tenders without giving any reasons thereof. He also reserves the right to increase the quantity of materials in case of necessity. The decision of the Collector & District Election Officer, Bargarh will be final.

9. The Firms /Persons whose tender will be accepted shall have to execute an agreement with the District Election Officer, Bargarh in Non-Judicial stamp paper worth of Rs 10/- only in the prescribed terms and conditions within two days from the date of acceptance of the tender and supply order will be issued only after the said agreement is executed.
10. Payment will be made within 15days after receipt of bills


