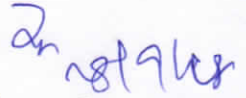

1- SCOPE OF SUPPLY

Successful bidder has to execute the **RENOVATION & MAINTENANCE** of plant on turnkey basis which includes Repair & Maintenance, supply, Erection & Commissioning of the equipments as mentioned in the Job Detail List. The Bargarh Co-operative Sugar Mills Ltd., shall only provide electricity, water supply free of cost and free accommodation cost for the engineers and staff. Utilities as specified by bidders shall be finalized during work finalization meeting.

2- ERECTION AND COMMISSIONING

- (i) Successful bidder shall be responsible for complete overhauling, erection, commissioning and handing over the Plant in due time as shall be indicated in the contract.
- (ii) Successful bidder shall take full responsibilities for unloading of equipment/parts at BCSM Ltd., site, opening the packages for inspection, storing of the equipment and leading the materials to the actual location for assembly and erection.

- (iii) Successful bidder shall assemble and erect all machinery and equipment in accordance with the drawings prepared by him and approved by the BCSM Ltd. and shall generally conform to acceptable engineering standards.
- (iv) Successful bidder shall carry out any and all other works that, may be necessary for proper commissioning of the equipment.
- (v) Successful bidder shall provide skilled, semi-skilled personnel including certified welders and unskilled labour for the entire work and supervise the overhauling, repairing and erection of the equipments.
- (vi) Successful bidder shall bring all the necessary tools and tackles required for the maintenance and erection work and instruments/apparatus required for testing. These tools and tackles, which the successful suppliers shall bring will remain his property, but can be removed from site only upon completion of work.
- (vii) Successful bidder shall arrange for all consumables, stores including temporary structural, gas, electrodes and welding rods for maintenance and erection purposes.
- (viii) Successful bidder shall provide a dedicated team of erection and commissioning engineers, who will co-ordinate the replacement, repair and maintenance, erection and commissioning of the equipment.
- (ix) The BCSM Limited will provide electric power required for erection, testing, start-up and commissioning of the equipment free of cost.

3- RESPONSIBILITY OF M/s. BCSM LTD.

- i) To provide workshop facility available, construction power and construction water free of cost at one point.

4- RESPONSIBILITY OF BIDDER

5- WARRANTY .

Successful Supplier shall provide a warranty covering the rectification of any and all defects in the design of the equipment, materials and workmanship of all items provided under this contract for a period of 18 months from the date of delivery or twelve (12) months after commissioning of Equipment, whichever is earlier.

6- INSPECTION AND TESTING.

General

The successful bidder shall conduct all test and inspection required for maintenance/ replacement of the equipment and submit details of the list of spare parts, material required for the carrying out the work, after duly approved by the BCSM Ltd., the bidders shall procure the material. The details Bill and vouchers should be submitted for record.

Material of Construction

All material of construction shall be of standard tested quality, material shall be tested as per the relevant standards and test certificate issued by the competent authorities shall be made available to the BCSM Ltd.. Material of construction of the Equipment supplied shall be as given hereunder.

For Pipes and Fittings.

All internal pipes and header pipes shall conform to IS:1239 part:1 up-to 150 mm NB and IS:3589 class 3 above 150 mm NB.

For Flanges

Flanges up to 20 mm thick shall conform to IS:6392 and above 20 mm thick shall conform to IS:2062.

At stage inspections to be witnessed by the BCSM Ltd.. All materials test certificates shall be correlated and verified with the actual material used for construction by the BCSM representative(s), before starting fabrication. In case mill test certificate for the material are available, successful supplier shall carry out physical and chemical tests at his own cost from a testing agency, approved by the BCSM, with the samples for testing being drawn up in presence of BCSM representative(s).
