

Technical Evaluation Criteria:

Bidders who fulfill all the below mentioned technical evaluation criteria will be considered eligible for compete in the Financial Bid.

Technical Evaluation Criteria

1	The Bidder should be a Proprietorship/ Partnership firm established in Odisha. 2	Tender fee/-	Rs 10,000/- in shape of DD drawn in favour of PD,DRDA ,Bargarh towards the cost of tender paper and the original money receipt shall be enclosed in tender paper failing which the tender shall be rejected.
3	The Bidder should submit an Earnest Money Deposit (EMD) of Rs 50,000/-	Demand Draft/TDR duly pledged in favor of Project Director, DRDA, Bargarh.
4	Validity of Tender	The approved rate will be valid for one year from the date of award of contract.
5	Procurement of Pictorial Tiles printed with AGAB Logo (2'x2' size)(Ceramic) of 10mm thickness double charged and printing must be Digital UV printed tiles with 16 pass using Pre and post coating without scratches. Must be Chemical proof (acid, water proof)	Approximately 2100 no. of Pictorial tiles printed with Ama Gaon Ama Bikash" are required to be installed at front of each project sites. The quantity may vary upon requirement of the office of the undersigned.

Note: All the documents must be self-attested by the Bidder. If the Technical Bid is found completed in all respect, then only Financial Bid will be opened, otherwise Financial Bid of the unsuccessful tenderers will not be opened.

Financial Bids

The Financial bids of only the successful Bidders in technical evaluation will be opened. Financial Bid must be submitted as per the format at **Annexure B**.

Earnest Money Deposit

As part of its Technical bid submission, the bidder would be required to submit an Earnest Money Deposit amounting to INR Fifty thousand (Rs.50,000/-) in form of a demand draft/TDR . The demand draft/TDR should be drawn in favour of **Project Director, DRDA, Bargarh** . The EMD of unsuccessful Bidders will be returned to the unsuccessful bidders immediately, after the selection of successful Bidder (without interest). For successful bidder, the EMD will be returned only after successful completion of delivery of pictorial tiles at block headquarters. Any bid submitted without EMD will be out rightly rejected. The Earnest Money will be forfeited because of one or more of the following reasons:

- The Bidder withdraws its Bid during the validity period as specified in Bid.
- The Bidder does not respond to requests for clarification of its Bid.
- The Bidder fails to provide the required information during the evaluation process or is found to be non-responsive or has submitted false information in support of its qualification.
- The Bidder materially alters his Bid during the Bid processing period.

Delivery Mechanism

The delivery of the pictorial tiles shall be made by successful Bidder at the Block headquarters. The damage during transit will be borne by the bidder. A random quality and quantity check will be conducted at the time of each delivery. If the quantity and quality is found to be non-satisfactory, the bidder will be liable to a penalty of up to 100% of the order value. The Bidder will obtain completion certificate from concerned Block Development Officers after successful delivery of the pictorial tiles and submit them along with bill for payment.
