QUOTATION CALL NOTICE FOR HIRING VEHICLES FOR MVU. OF BARGARH DISTRICT

Sealed quotation in prescribed proforma in Annexure are invited from the Travel agencies / Individuals for hiring of vehicle preferably jeep model (BOLERO / TATA SUMO / MARSHAL etc...non AC) on, monthly rent basic for the year 2018-19 for Mobile Veterinary Unit for Attabira, Ambabhona Block of Bargarh district Interest Travel Agencies / Individuals may submit their offers mentioning DOL consumption in Kms / Ltr and hiring charges per month.

Maintenance of the vehicle and payment of Road Tax and insurance will be borne by the owners. The following guidelines may please be adhered to.

1. The vehicle must be in road worthy condition, shall not be more than 5 years old from the date of initial registration & must have valid registration certificate, insurance certificate, fitness certificate, Taxipermitt& proof of up to date tax payment.
2. The owner will provide Licensed driver & salary of the driver will be borne by owner.
3. All minor / major repairs will be borne by the owner.
4. The licensed driver should wear a uniform he should be a non-alcoholic and should be availed as and when required.
5. The vehicle will be kept in the office campus of the concerned Veterinary Dispensary.
6. In case of absence of driver for whatever reasons the owner shall arrange substitute for the vehicle.
7. The vehicle should be kept clean and tidy and should have name board & sticking as specified in the contract on the vehicle.
8. Vehicle should be regularly serviced and maintained so as to avoid any break down. In case of breakdown an alternative vehicle should be arranged for without compromising the service of M.V.U.
9. No extra charges will be paid for night halts at out station and the lodging / boarding charges of the driver will be borne by the owner of the vehicle.
10. The vehicle is to be preferably of white colour / Silver Grey.
11. In case of similar quoted price, preference will be given to local vehicle /new vehicle (Preferably of same block which the vehicle is quoted for)
12. If the approved vehicle owner fails to provided vehicle for more than two consecutive days, where the work of Mobile Animal Health unit will be hampered due to this reason, his hiring amount due to be paid will be forfeited and the agreement between undersigned and the vehicle owner will stand cancelled automatically.
13. Vehicle must accommodate 3 person with all needed equipment and, materials. There should be space for keeping Laboratory Equipment's, Medicines etc.
14. The owner has to supply DOL for the month until re-imburement of the HSD bills.
15. An agreement will be made with the vehicle owner before engagement of his vehicle on M.V.U. work.
16. The successful bidder should deposit security of Rs.5000/- (Rupees five thousand) only before signing the agreement for engagement of MVU vehicles.

Vehicle owner / Travel Agencies desirous of giving their vehicle on the monthly rental basic with above term & condition may submit their offers in the prescribed format addressing to the "Chief District Veterinary Officer, Bargarh" in sealed covers super scribing "Quotation for hiring of vehicle of MVU" along with the Xerox copies of the following documents. The sealed quotation should reach the undersigned on or before by 28.02.19 at 1.P.M. and the quotation will be opened on the same day at 4P.M. in presence of the quotationer / representative. There is no bar for opening of quotation through the quotationer / representative absent as per scheduled time.

- b. Up to date tax payment receipt.
- c. Insurance of the vehicle.
- d. Valid DL of the driver.
