

Sealed Quotation are invited from interested reputed Travel Agencies/Tour Operators or Private individuals ownerhaving for providing Non AC/AC diesel driven vehicle preferably **Indica eV2, Indigo, Swift Dzire, Zest, Scorpio, Xylo, Innova/Tavera/XUV-500/TUV-300/Bolero, Tata Sumo and Tempo, Pickup Van/407**, vehicle as and when basis and transport vehicle for official use of District Project Office, RtE-SSA, Bargarh subject to the terms and conditions (Annex-I)

1. The vehicle must be in Road Worthy condition, shall not be more than 03 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage permit, proof of up to date tax payment, Taxi No. for hire use etc. which mandatory for plying of vehicle as & when basis. The interested party must have valid GST Registration Certificate and PAN.
2. The Driver of the vehicle must have valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle, non-alcoholic and obedient in nature.
4. **Earnest Money Deposit (EMD):-** A sum of Rs.15,000/-(Rupees fifteen thousand only) shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **District Project Coordinator, RtE-SSA, Bargarh** payable at **Bargarh** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders. Bid submitted without EMD will summarily be rejected.
5. The bidder should quote both Technical and Financial quotation in form-A & B-I, B-II separately.
6. The rate of hire charge is to quote (**Excluding POL and GST**) in the Financial Bid (Format-B-I for hiring of vehicle Indigo, Bolero, Tavera etc & B-II for transport goods/materials vehicle).
7. The vehicle must achieve a minimum average mileage (Km per liter of diesel to be reimbursed) to be quoted should not be less than as per latest Finance Deptt. Office Memorandum No.-27037 dtd.08.10.2015. i.e. Innova-09, Tavera-10 kmpl, Bolero- 10 kmpl, Tata Indigo-15 kmpl & Swift Dzire (Diesel)- 17 kmpl, Swift Dzire (Petrol)-14 kmpl, Indica eV2-17 kmpl
8. The details of the make and year of manufacture of the vehicle, registration no., GST Registration Certificate, PAN No.etc. and name of the Driver with Driving License No. and period of validity should be specifically provided in the technical bid information to be furnished with the Quotation (Technical Bid-A).



The sealed envelope superscribing as "QUOTATION FOR HIRING OF VEHICLE AS& WHEN BASIS". D.P.O., RtE-SSA is not responsible for any postal delay. The quotation shall be opened on the **19.03.2019 at 4.30 p.m.** in presence of the bidders or their authorized representative.
10. The application form of quotation containing Technical Bid information & terms and conditions for Hiring of Vehicles etc. will be available with **District Project Office, RtE-SSA**. Bargarh on payment of Rs.200/-(Rupees two hundred only) from **06.03.2019 to 18.03.2019 by 5.00 p.m.** from cash section excluding Sunday & holidays or can be downloaded from official Website www.bargarh.nic.in from **06.03.2019 to 18.03.2019 by 5.00 p.m.** In case the application form is downloaded from website, the applicant shall furnish a Demand Draft for an amount of Rs.200/-(Rupees two hundred only) in favour of **District Project Coordinator, RtE-SSA, Bargarh** payable at **Bargarh** towards the cost of application along with the application.
