1. The text of the materials will be provided by ORMAS well in advance of the exhibition. It is the responsibility of the firm that the print materials without any mistake should be provided in time as per the specification.
2. Sanctions of any advance will not be considered. The payment will be made on completion of each event.
3. The bidders are required to deposit an earnest money of Rs. 2000/- (Rupees Two Thousand only) in shape of demand draft/pay order in favour of DSMS, Bargarh payable at Bargarh. The E.M.D. amount of the successful bidder will be kept with ORMAS till the completion of the exhibitions. In case of any unsatisfactory work, delay in execution of work etc. the E.M.D amount will be forfeited as per the decision of the authority. Tender papers without E.M.D shall not be accepted.
4. The rate offered by the firm should be valid till completion of the Event.
5. The tender must be delivered at the specified address as per the Bidder Data Sheet by Speed post / Registered Post only. The Client shall not be responsible for postal delay or any consequence. Submission of proposal through any other mode will be rejected.
