

i. Schedule of contract, Terms & condition – Annexure “A”

In consideration of the payment to be made by the “Authority” to the “Out Sourcing Agency” hereby covenants with the “Authority” to provide illegible manpower that means “11 nos. of Peon and 1 no of Chowkidar & 1no of Driver” shall be engaged in the ARD Sector, Bargarh in conformity with the provisions of the contract.

The “Authority” hereby covenants to pay the “Out Sourcing Agency” the contract price of the Rs. 8070/ & Rs.8880/- with other charges as per Govt. guidelines deployed to aforesaid Department at the time and manner prescribed in the contract.

In the event of any dispute that may arise and in case the matter is referred to Court of Law, the competent court within Jurisdiction of Bargarh shall have the “Authority” to decide and dispose of the litigation.

In witness where of the parties have caused their respective common seals to be here into affixed or have here into set their respective hands and seals on the day and year first written above.

This is valid for one year (12 calendar months) (.....) from the date of commencement of the execution.

It can be renewed yearly basis if the performance of the Out Sourcing Agency/Performance of Employees will be found satisfactory on review. But, for renewal of agreement the Out- sourcing agency is to apply before the authority 1 month before 1 month of expiry of validity of the agreement.

SCHEDULE OF CONTRACT, TERMS & CONDITION OF CONTRACT

1. The deployment of manpower for Peon/Chowkidar /Driver shall be on monthly basis with a payment of per month Rs. 8070/- & Rs.8880/- with other charges as per Govt. guideline (including all taxes) for each candidate.
2. The "Out Sourcing Agency" raise bill once in a month for payment and attached with ECR copy of 2nd month onwards.
3. The payment will be made to the service providing organization on monthly basis on availability of fund.
4. The Peon/Chowkidar/Driver should join in their work as per working time table of ARD Deptt. In different institutions in working days and shall not leave office before schedule time without permission from their immediate authority. They will attend the office work beyond the office hours and even on Sundays and Govt. Holidays if required or in case of emergency.
5. The "Authority" has the right to ask "Out Sourcing Agency" to withdraw/replace the Peon/Chowkidar/Driver who has been reported by the "Authority" as disobedient towards his/her service being rendered. The "Out Sourcing Agency" agrees to acts promptly on such request by the authority.
6. The Peon/Chowkidar/Driver are to maintain the secrecy of the official business concerned. If it will come to the notice of the "Authority" at the latter stage the "Out Sourcing Agency" is liable for such committed offence and decision of the "Authority" as deemed proper is final.
7. The "Out Sourcing Agency" is to be bear/compensate any loss/damage to Govt. property by the Peon/Chowkidar/Driver.
8. The agreement so executed shall be terminated on written notice of two months from either side.
9. Any other problems arises and brought to the notice of the "Authority" shall be decided as per existing Government Rules, Regulations and Stipulation as deemed proper.


