

**ELIGIBILITY CRITERIA AND SELECTION PROCEDURE FOR RECRUITMENT OF DISTRICT
DATA MANAGER UNDER IDSP-NHM-BARGARH**

Qualification: The candidate must have passed in any of the following subject from a recognized University / Institution with minimum 50% marks.

M.Sc in Computer Science or IT/ Master in Computer Application/ B.E in Computer Science or IT or Electronics / B.Tech in Computer Science or IT or Electronics

Experience: S/He must have minimum 01 years of post qualification experience in health or Social Sector.

Age Limit: 21 to 40 Years (as on 01.09.2020)

Selection Procedure:-Total marks 100:- Written (50 marks) + Computer (30 marks) + Viva Voce (20 Marks)
