SEALED TENDER NOTICE

1. Sealed tenders in plain papers for sale of one TATA INDIGO CS (Diesel) without accessories of the Office of the District Judge, Bargarh bearing Regd. No. OR-17-J-3737, Model-2011 are invited so as to reach the office of the District Judge, Bargarh on or before dtd. 05.05.2021. The intending parties should write in capital letters on the top of the envelope "**Sealed tenders for the vehicle bearing Regd. No. OR-17-J-3737**". The tenderers shall drop the sealed tenders in the box kept for the purpose at the Nizarat section of Office of the District Judge, Bargarh between 07.00 A.M. to 11.00 A.M. on all working days till 05.05.2021.
2. The vehicle is available for inspection inside the Court premises on workings days during the office hours between 07.00 A.M. to 11.00 A.M. from the date of publication of this advertisement. The inspection may be made with the help of Nazir.
3. Earnest money of Rs.1,000/- (Rupees One Thousand) only shall be deposited in the shape of bank draft (A/C payee only) in favour of District Judge, Bargarh and the bank draft be enclosed with the tender application. The tenders received without bank draft shall be rejected summarily.
4. The tenders shall be opened by the undersigned on 05.05.2021 at 12 Noon, in presence of the tenderers and or their authorised representatives. The unsuccessful tenderers shall get return of their earnest money deposited bank draft forthwith.
5. The highest tenderer shall deposit 25% of the amount offered immediately on the spot soon after the announcement and the balance amount shall be deposited within 7 (seven) days of the approval of the offer and on failure to make payments as aforesaid deposits including earnest money shall be forfeited and the vehicle shall be put to fresh auction as the case may be.
6. The vehicle shall be removed from the court premises on the same day after depositing the full amount of tendered money together with the VAT at the prescribed rate. The custody or safeguard of the vehicle shall be the responsibility of the tenderer in case non taking of the vehicle and no claim or complaint on that account shall be admissible.
7. On failure to remove the vehicle within the time as aforesaid, ground rent @ 1% of the tendered money shall be charged for each day or part of the day till removal of the vehicle from the site. In case the ground rent exceeds the sale price deposited, the party will cease to have any right over the vehicle and the

amount deposited towards the sale proceeds will be adjusted towards the ground rent and the vehicle shall become the absolute property of the Court free from all encumbrances.


8. The authority reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
