The envelope must be super scribed by “Auction of EMAS Ambulances (TATA Winger-108) -2020-21”.The tender shall be opened on Dt.29/06/2021 at 11.30A.M at DTU, NHM, Bargarh in the presence of bidders or their authorized representative.
3. Interested bidders can obtain detailed terms and conditions from the website for bidding in Auction. The bidder can download the tender documents from district website i.e. www.bargarh.nic.in. (Address of district website).
4. Bid will be submitted in two parts i.e. Technical Bid (Cover – A) and Financial Bid (Cover – B). The bidders should give their technical and financial proposal separately in two envelopes and both should be put into third cover which should be super scribed as “Auction of EMAS Ambulances (TATA Winger-108) -2020-21”.


5. Bidder will have to submit Demand Draft of Rs. 500/- (Rupees Five Hundred only) as tender paper cost (non-refundable) in favour of ZSS, Non-NRHM funds, Bargarh along with bid document.
6. Bid documents must be accompanied with EMD of Rs.10,000/- (Rupees Ten Thousand only) in shape of Demand Draft drawn on any Nationalized Bank in favour of ZSS, Non-NRHM funds, Bargarh payable at Bargarh.
7. Bid documents without EMD and tender paper cost will be summarily rejected. EMD of unsuccessful bidders will be returned without interest on finalization of tender. EMD of successful bidder will be retained as Security Deposit & will be refunded without interest only after the successful bidder removes the vehicle after deposit of full amount as finalised in the auction along with GST and other dues if any. Security deposit is liable to be forfeited if bidder violates or fails to comply with the terms and conditions of the tender.
8. Bidders will have to submit following documents in order to qualify for the auction sale:
 - a. Photo copy of PAN Card.
 - b. Photo copy of AADHAAR Card.
 - c. Photo copy of GST registration certificate (if available).
 - d. Photo copy of last GST return filed (for registered parties).
 - e. Tender paper cost in shape of Demand Draft of Rs. 500/- (Rupees Five Hundred only) (non-refundable) in shape of Demand Draft drawn on any Nationalized Bank in favour of ZSS, Non-NRHM funds, Bargarh payable at Bargarh.
 - f. EMD in shape of Demand Draft of Rs.10,000/- (Rupees Ten Thousand only) in shape of Demand Draft drawn on any Nationalized Bank in favour of ZSS, Non-NRHM funds, Bargarh payable at Bargarh.
9. All documents submitted must be signed by the authorised signatory of the organisation with seal.
10. Auction will be held on **"AS IS WHERE IS BASIS"**.
11. Highest bidder will be given preference for receiving auctioned vehicles.
12. Both registered and unregistered Bidder will have to bear GST as applicable on auction sale of ambulances. GST @ 18% applicable on auction price.
13. The successful bidder shall get the vehicles transferred as per rule and only after submission of full price finalised as per auction. The bidder will have to deposit the full amount including GST (as applicable) either in shape of Bank Draft or have to deposit cash in **ZSS (Non - NRHM funds), Bargarh** having Savings Bank account no: **30246106129** and produce deposit slip as a proof for payment of full auction price of ambulances. There after bidder will be allowed to remove the vehicles.
