1. **Scope of Work**

The Bidders will have to supply one Ply mounting for IFP cum White Board per school for digital class room as per the specifications provided in the tender which will be used as a support to the Interactive Display Panel as well as teaching.

2. **GST Certificate**

The Bidders i.e. the Studios/firm/dealer must have valid GST certificate, PAN card.

3. **EMD**

The Bidder shall submit EMD of Rs. 3700/- (Rupees Three Thousands Seven Hundred) only in favour of BDO JHARBANDH in shape of demand draft from any nationalised /scheduled bank payable at Jharbandh.

4. **Performance Security Deposit**

The Bidder shall submit one Performance Security Deposit (PSD) of Rs. 11000/- (Rupees Eleven Thousands) only in favour of BDO JHARBANDH in shape of demand draft from any nationalised /scheduled bank payable at Jharbandh. The PSD is refundable.

5. **Experience**

The Firm/ Dealer should have experience of executing or supplying of similar items.

6. **Undertaking as to litigation/Black Listed**

The bidder shall submit self certified undertaking to the effect that there is no major legal cases pending against it or him and not being black listed by Govt. of Odisha and any other Govt. of union territory and other authorities.

7. **Instructions to Bidders**

- Bidders desirous for participating in the Tender, shall have to pay the Tender cost mentioned in notice inviting Tender. The Tender cost is required to be paid in shape of Demand draft only, drawn from any nationalized/scheduled bank in favour of BDO JHARBANDH which must be payable at Jharbandh. The Tender cost is inclusive of GST and is not refundable.
- Earnest money as specified in Tender shall be deposited in shape of Demand Draft from any nationalized/scheduled bank in an acceptable form at the time of submission of Tender.
- Since, timely execution of works is the essence of the contract, requests for extension of time shall not ordinarily be entertained.
- Notice inviting Tender, Tender documents, prescribed Tender, terms & conditions shall form the part of the Tender.
- The price quoted by the Bidders shall be inclusive of all taxes & transportation .
- Deviations in terms and conditions will not be accepted under any condition.
- Prices quoted must be firm and fixed. It shall be quoted in both figure and word. It should be inclusive of GST.
- Canvassing in any manner will be viewed seriously leading to rejection of the Tender.

8. **Settlement of Dispute**

In case of any dispute arises between the supplier and purchaser shall be tried to resolved amicably by mutual understanding. If the parties fails to resolve the dispute within 21 days shall be settled through arbitration under the jurisdiction of Bargarh Court only as per Indian Arbitration and Conciliation Act-1996.

9. **Delivery Mechanism**

The delivery of the items as per the list of each location shall be made by the bidder at the respective schools. A random quality verification will be conducted at the time of each delivery. If the quality and/or quantity is found to be non-satisfactory, Bidder will be penalized up to 100% of the Order value.

10. **Payment**

Payment shall be made after random inspection of supplied materials by the Inspection team and if found satisfactory.
