The Block Development Officer, Bargarh invites sealed tenders on behalf of Governor of Odisha on percentage rate basis from registered and eligible Contractors of the state PWD(R&B)/Water Resources/Rural Works/MI/CPWD for the following works eventually to be drawn up in the PWD P-I form in conformity with the Detailed tender call notice. The bidders may submit bid for the following works.

Terms and Conditions

- 1 Cost of tender paper :-** The tender specification can be obtained from the Block Development Officer, Bijepur on payment towards the cost of tender paper as mentioned above in shape of Cash/Demand Draft /Banker Cheque (Non-refundable) issued from any Nationalized Bank drawn in favour of **Block Development Officer, Bijepur** payable at **State Bank Of India, Bijepur Branch** in any working days from **dt. 21.12.2021**.
- 2 Sale of Tender Paper :-** The tender documents will be sold from **dt: 21.12.2021** at Block Office, Bijepur. The tender documents will be sold during the above mentioned period between **10 AM to 2 PM** on working days only.
- 3 Date of receipt and mode of submission of tender papers :-** The tenders have to submit the sealed papers in complete shape through Registered Post / Speed post / Tender box only **up to 2 PM on dt. 24.12.2021** . The undersigned will not be responsible for any postal delay if any or non-receipt of the papers in time. The tenders must super scribe the name of the work project on sealed envelopes.
- 4 Date of Opening of tender paper :-** The tender papers shall be opened on **dt: 24.12.2021 at 3 PM** in the presence of the Contractors or their authorized representatives having written authorization for the purpose and the tender committee.
- 5 Earnest Money Deposit :-** The E.M.D. is to be deposited in shape of Post office short term deposit /Term deposite /N.S.C /KVP / Deposit receipt of any nationalized Bank duly pledged in favour of **Block Development Officer, Bijepur**. The tender paper without required amount of EMD will not be considered and transfer or adjustment of EMD is also

in admissible.

6 Document to be attached :-The following documents should be furnished with the tender papers failing which the tender will liable to rejection.

- (a) E.M.D pledged in favour of Block Development Officer,Bijepur.
- (b) Attested copy of Contractor Registration Certificate.
- (c) Attested copy of PAN card /GSTIN clearance certificate / upto date I.T.C.C.
- (d) Attested copy of labour license.
- (e)The bidders has to furnish Ownership certificate of possession of required T & P and machinaries for the above work,if plants and machinaries not own by him/them and(the intending tenderers shall have to furnish proof and machinaries in their possession and or lease deed for hiring of such machinaries from the rightful owners duly executed by Executed Magistrate/Notary should be produced along with tender paper for consideration of tender and Original certificate produced before the B.D.O.Bijepur at the time of opening of the tenders.
- (f) Certificate from the officer not below the rank of an Executive Engineer or above regarding execution experience minimum 70 % quantity of the tender items in a year in last two years.
- (g) Attested copy of Caste Certificate issued by Competent Authorities in case of S.C./S,T. Contractors desirous of aviling preference.
- (h) Affidavit as regards the fact of aviling award of work without submission of E.M.D/I.S.D during the current financial year in case of Engineer Contractors desirous of aviling exemption of E.M.D.
- (i)Affidavit about the authentication of tender documents including bank guarantee.
- (j) Certificate of no Relation ship.

7 The rate should be quoted in terms of % (percentage) less/excess/equal to one decimal point only over the tender value of the amount put to tender (Both in words & figures in details.


8 Every tenderer is expected before quoting his rates to inspect the site of proposed work. He should also inspect the quarries and satisfy himself about quality,availability of medicals aids,labour and food stuffs etc.and the rates may be inclusive of all these times of work in every case the materials must comply with the relevant specification and samples of materials in sealed bags may be submitted along with the tender for approval of the higher authority.

9 If any of the bidder quotes less than 15 % of the tendered amount ,then such a bid shall be rejected and the tender shall be finalized basing on merits of the rest bids. But if more than one bid is quoted at 14.99 % (Decimals upto two numbers will be taken for all practical purposes) less than the Estimated cost the tender accepting authority will finalized the tender through a transperant lottery system,where all bidders/their authorized representatives.

10 Additional Profermance Security Deposit :- (a) When the bid amount is upto 10 % less than the estimated cost,no additional security is required to be deposited. When the bid amount is less than the estimated cost by more than 10 % and within 15 %,in such an event the bidder will have to deposite the A.P.S.D. to the extent of 1.5 times of the differential cost of the bid amount and 90 % of the estimated cost in shape of Post Office term deposit / N.S.C. / K.V.P. / Deposit receipt of any Nationalized Bank duly pledged

in favour of Block Development Officer, Bijepur along with tender paper.

- (b) The performance security shall be obtained from the bidder when the bid amount is less than the bid cost put to the tender. In such event, the bidders who have quoted less bid price/rates than the bid cost put to tender shall have to furnish the exact amount of differential cost i.e., bid cost put to tender - (minus) the quoted amount as Performance Security in shape of Demand Draft/ Term Deposite receipt pledged in favour of B.D.O. Bijepur. in the sealed envelope in absence of which the tender will be summarily rejected.
- 11 **Forfeiture** :- The E.M.D. amount will be forfeited, if the tenderer backs out from the offer acceptance of tender, by the competent authority.
- 12 Submission of more than one tender paper by a bidder for a single work will be liable for rejection of such tender papers.
- 13 On review of the last performance of the works executed through Block Development Officer, Bijepur previously, the lowest - 1 tender may / may not be considered for the works, through he/she becomes lowest - 1 tenderer.
- 14 The Contractors who have failed to execute projects of this agency / backed out from execution process / abandoned the project work midway / those have been declared by this agency to be defaulters. Otherwise will not be allowed to participate in the present tender process. If any of such Contractors then his/her papers will not be considered at all.
- 15 G.S.T. shall be paid extra as applicable.
- 16 The Block Development Officer, Bijepur reserves the right to either reject any or all tenders or cancel the entire process without assigning any reason thereof.


