

3. Sealed Bids must be enclosed with appropriate cost in shape of a non-refundable Demand Draft, separately issued from any scheduled bank payable at Gaisilet in favour of **Block Development Officer, Gaisilet**.
4. The receipt of the bid documents shall start from 10.00 AM on dt. 07.01.2022 to 12.01.2022 till 4.00PM only through Registered post/Speed Post address to the **Block Development Officer, Gaisilet, At/PO:Gaisilet, Dist: Bargarh, PIN: 768037**
5. The bid will be opened on Dt. 13.01.2022 at 03.00 PM in the Office of the undersigned in the presence of the bidders who wish to attend. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be sold and received on the next working day at the same time and venue and opening of the bids accordingly extended. Similarly, if the office happens to be closed on the date of opening the bids will be opened on the next working day at the same time and venue.
6. Bidding documents requested by mail will be dispatched by registered / speed post on payment of an extra amount of Rs.500.00 (Rupees five hundred) only over the cost of the document. The B.D.O., Gaisilet will not be held responsible for postal delay if any.
7. Sealed Bids should be accompanied with the attested true copies of the valid registration certificate, GSTIN and PAN card which are mandatory and the original certificate are to be produced within three working days of opening of the tender before B.D.O., Gaisilet for verification otherwise his / her bids shall be declared as non-responsive and thus liable for rejection. Also, the Tenderer should satisfy the eligibility criteria, provided in the relevant clauses of the bid documents (DTCN)
8. Bidder can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers.
9. The bidder shall have to deposit 1% EMD i.e. Rs. 12329 .00 of the Tendered amount in shape of Term Deposit Receipt pledged in favour of **Block Development Officer, Gaisilet /Bank Guarantee in favour of the Block**

**Development Officer, Gaisilet** from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar.




