**ELIGIBILITY CRITERIA FOR SELECTION OF WSHG/FEDERATION MEMBERS TO ACT AS BUSINESS CORRESPONDENT AGENT IN UNBANKED/UNDERBANKED GPS**

- Must be a Woman SHG member.
- Should be in the age group of 18 to 45 years.
- Must have passed 10<sup>th</sup> standard (matric). (preference will be given to higher academic qualification).
- Well conversant with local language / dialect and able to read & write.
- Must be from the same locality (GP).
- Must be capable of operating computer / laptop / smart phone or can be trained for the same.
- Must have good communication skill.
- Must have KYC documents like Aadhar / Voter ID, PAN.
- Must have ability to deposit the security deposit of Rs. 25,000/- and to meet the cost of infrastructure like furniture, computer / laptop, internet connection, biometric devices, web camera, Micro ATM etc. and books of record costing around Rs. 50,000/-.
- Should have adequate space for operating the CSP (Customer Service Point).
- Should not be a full time or part time employee of any Government / Non-Government organisation / Local Self-Governance body.






