But successful bidder of other State / MES / Railway / CPWD in equivalent rank has to register under the State PWD before signing the agreement. The bidders may submit bid for the following works.

Tender documents consisting of specification & schedule of quantities (BOQ) and the set of terms and conditions of contract (DTCN) along with other necessary documents can be obtained/download from district NIC website www.bargarh.nic.in from dt.14.10.2022 at 10a.m to dt.28.10.2022 till 1.00 p.m.
3. Sealed Bids must be enclosed with appropriate cost in shape of a non-refundable Demand Draft, separately issued from any scheduled bank payable at Jharbandh in favour of **Block Development Officer, Jharbandh.**
4. The receipt of the bid documents shall start from **10.00 AM on dt. 14.10.2022 up to 1.00 PM dt.28.10.2022 only through Registered post/Speed Post address to the Block Development Officer, Jharbandh At/PO: Jharbandh, Dist: Bargarh, pin: 768042.**
5. The bid will be opened on **dt.29.10.2022 at 11.00 AM** in the office of the under signed in the presence of the bidders who wish to attend. If the office happens to be closed on the last date of sale and receipt of the bids as specified, the bids will be sold and received on the next working day at the same time and venue and opening of the bids accordingly extended. Similarly, if the office happens to be closed on the date of opening the bids will be opened on the next working day at the same time and venue.
6. Bidding documents requested by mail will be dispatched by registered / speed post on payment of an extra amount of Rs.500.00 (Rupees five hundred) only over the cost of the document. The BDO, Jharbandh will not be held responsible for postal delay if any.
7. Sealed Bids should be accompanied with the attested true copies of the valid registration certificate, GSTIN and PAN card which are mandatory and the original certificate are to be produced within three working days of opening of the tender before BDO, Jharbandh for

verification otherwise his / her bids shall be declared as non-responsive and thus liable for rejection. Also, the tenderer should satisfy the eligibility criteria, provided in the relevant clauses of the bid documents (DTCN)

8. Bidder can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers.
9. The bidder shall have to furnish a **"BID Security declaration"** as per the Office Memorandum No.8943 dtd.18.03.2021 of Finance Department, Government of Odisha in lieu of Bid Security in the format annexed Form of Bid Security Declaration along with the bid.
10. Other details can be seen in the bidding documents.
11. The enclosures other than the D.T.C.N. should be page numbered and signed by the contractor.
12. Total No. of enclosures should be submitted by him / her in Numbers and words as per relevant clause of D.T.C.N.
13. Envelope should be superscribe with tender call notice number, name address and phone number of the bidder.
14. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
