NOTIFICATION

In exercise of the powers conferred by sub-sections(3) and (3A) of Section 12 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950) read with sub-rule(1) of rule 2A of the Odisha Municipal(Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, notice is hereby given that the **Attabira Notified Area Council** in the district of **Bargarh** shall be divided into **12(Twelve)** Wards as specified in Column(2) of the Statement-I below with the description and boundaries of the said Wards against each in Columns(3) and (4) respectively thereof for the purpose of ensuing election of Councilors to the same and the Wards as specified in Column(2) of the Statement-II below in which the seats reserved under section 11 of the said Act, shall be set assigned against each in Column(3) thereof.

Objections or suggestions received after the said period shall not be taken into consideration.




