## For Outsourcing Agents for BMW Management in District Head Quarters Hospital/ Sub Divisional Hospital/ CHCs /Non Bedded PHCs.

### Eligibility

Following points should be fulfilled by the tenderer to be eligible for participation in the bidding process:

1. The firm/agency/company should have a valid registration certificate.
2. It shall have valid EPF, ESI & Service Tax Registration Certificate.
3. It must have PAN and GST registration in the name of the Firm/ Agency/ Company.
4. It must have valid labour license.
5. It must not have any previous record of contract termination, being black listed or left out of the job etc.
6. The bidder should have to submit the valid license from the OSPCB (Odisha State Pollution Control Board) or has to submit an undertaking to produce the same within two months after signing of the MOU with the undersigned.

### General Terms & Conditions

1. In order to finalize the tender smoothly, the price bid will be evaluated considering the total cost per day for all the services (outsourcing, transportation and disposal of Bio Medical Waste of DHH, SDH, CHC and PHCs) and accordingly L1 bidder will be decided. The unit cost for each service quoted by each bidder will be multiplied by the number of functional beds, KM estimated to be covered and number of non bedded health care facility as per Annexure -1.
2. The outer envelope should contain cover-A & cover-B inside & should be properly sealed & super scribed on the envelope "**Tender for Engagement of Outsourcing Agency under BMWM Activities for Bargarh district**".
3. Cover & Documents-  
**Technical Bid – Cover- A** - The following documents should be furnished in a sealed cover super scribed as "**Technical Bid for Engagement of Outsourcing Agency under BMWM Activities for Bargarh district**". The documents should be enclosed with Index & Page No-
  - a. The tender document should be accompanied with Bank Draft of **Rs.5900/-** (Rupees Five Thousand Nine Hundred only) (Non-refundable towards Cost of Tender Document) by way of separate Demand Draft drawn in favour of **Bio Medical Waste Management of Bargarh Dist**, payable at Bargarh from any Nationalised Bank.
  - b. Detail Name & Address along with the contact number & email address of the Director/Managing Partner/ Proprietor of the Firm are to be clearly mentioned in capital letter.
  - c. Attested Copy of the IT Return for last three Financial Years. i.e., 2019-20, 2020-21 & 2021-22.
  - d. Attested Copy of the PAN Card.
  - e. Attested Copy of the up to date GST Clearance Certificate.
  - f. Experience Certificate in the respective field if any.
  - g. An undertaking from the agency affirming that it has not been blacklisted and is not involved in criminal proceeding relating to execution of Bio Medical Waste Management services.
  - h. **EMD Rs. 30,000/-** in Shape of DD/ Bankers Cheque drawn in any Nationalised Bank in Favour of the **Bio Medical Waste Management of Bargarh Dist**, payable at Bargarh (Refundable without interest).
  - i. Original Documents are to be produced during opening of the tender documents.

**Financial Bid – Cover-B** – The price quoted should be as per format given in Annexure-1 & signed by the bidder with seal.

4. The EMD of the unsuccessful bidder will be returned after finalisation of the tender process.
5. The EMD of successful bidder will be returned after completion of assigned work as per requirement.

6. The EMD will be forfeited if the bidder fails/refuses/non T compliance in any aspect to execute the work orders within the stipulated time period.
7. Tender documents can be computerised without any correction & overwriting.
8. All the workers engaged by the outsourcing agency shall have uniform with the logo of the Agency.
9. All staff of the OS agency shall bear photo identity cards during the period of work, which shall be duly signed by the Head of the concerned Hospital (DMO (MS)-Superintendent for DHH, Superintendent for SDHs, MO I/C for CHCs and PHCs) and representative organization.
10. The Agency should be operating/tied up with one CBWTF with valid authorization from OSPCB as per BMWM rules 2016 & Amendment 2018 before executing the work.
11. The selected agency should provide different services under Bio Medical Waste management as per guideline laid down in BMWM rule 2016 & Amendment 2018.
12. The Outsourcing Agency shall furnish the List of workers & supervisors (above 18 years of age only) with Proof of Identity and address to the Head of the concerned Hospital after finalization of the contract for Outsourcing of services.
13. All the personnel to be engaged by the Organization/Agency should be covered under the statutory Government regulations (Labour laws & regulations) framed from time to time.
14. The concerned authority of the Hospital may request the Tenderer/Agency to withdraw any of their workers from the Hospital without assigning any reasons, with 24 hours prior intimation.
15. The Tenderer/Agency will abide by all the rules and regulations relating to labour laws, accident, workmen compensation act, Workmen Insurance, ESI, PF, fire safety etc. This will be the sole responsibility of the Tenderer/Agency. The authority will not be a party at any stage to any kind of dispute if arises relating to the above.
16. Any damage/pilferage to the Hospital property due to mishandling/carelessness of the agency or his workmen will be recoverable from the Agency's bill and all materials issued to the contractor/Agency shall be his/her sole responsibility for its safety during the entire period of the contract.
17. The selected Agency should engage qualified and dedicated staff (trained in the field of Bio Medical Waste Management or having experience in handling the biomedical wastes) to manage the Bio-Medical Waste Management activity such as collection, transportation, storage, treatment & disposal in the Hospital premises (offsite/onsite). It will also coordinate with the Bio-Medical Waste Management Committee of the Hospitals and be responsible for supervision of the said work. The work men should be provided with mobile number (24 X7 functional) for emergency need at any time by the Agency.
18. All the employees of Agency will have to be covered under insurance against any personal accident/health hazard and the Hospital authority will not be liable for payment of any compensation on that account.
19. During execution of work, the Agency should follow all standard norms of safety measures/precautions to avoid accidents/damages to men, machine and infrastructure etc. On non adherence to this clause, suitable fine/penalty as decided by the Authority will be imposed.
20. All the generation points of BMW at Health care Units (DHH/SDH/CHC/PHC) must have colour coded container/bins with cover. The designated bio-degradable colour coded waste bags with bio hazard symbol will be put in respective coloured coded container/ bins and lifted by the OS agency when they become two third full. Bags are to be closed by tying a string, weighed and recorded and then transported to the temporary storage area (onsite/offsite) for treatment and disposal utilizing the BMW equipment (Onsite/Offsite). Each bag shall be labelled as per BMWM Rules 2016 & Amendment 2018. The colourcoded bags shall be strong enough to withstand any possible damage that may occur during loading, transportation or unloading. The colour coded containers in the transportation vehicles shall be provided by the outsourcing agency which shall be labelled as per BMWM rules 2016 & Amendment 2018. Segregated sharps shall be collected from all generation points of the Health care Units in separate colour coded bins. Mutilated infected plastics must be collected and properly disinfected/autoclaved by the OS agency before shredding. The person identified for collection of Bio-Medical Waste must carry a register with him to maintain the record such as name of the generation point, type and quantity of

- waste received, date and time of collection with signature of the responsible person (MO/Pharmacist/LT/I/C sister of the ward). A similar register is to be maintained by Matron/MO I/C/ Superintendent for BMWM.
21. The out sourcing agency has to give attention that no Untreated Biomedical Waste is kept in the hospital premises beyond 48 hours. In case it is beyond 48 hrs, it must obtain the permission of OSPCB for the purpose.
  22. The collection and transportation of Bio-Medical Waste shall be carried out in a manner so as to avoid any possible hazard to human health and environment. The timing of collection of the waste will be preferably before 8.00 AM.
    - a. The Bio-Medical Waste segregated in biodegradable Poly bags/ containers shall be collected from generation points of HCEs (DHH/SDH/CHC/PHC) and transported to the nearest BMW Management unit located at DHH/SDH or offsite BMW treatment plant in a fully covered vehicle. Such vehicle must be labelled with bio hazard Symbol and dedicated for transportation of Bio Medical Waste only and to be provided by the OS Agency/ Organization.
    - b. The Agency/Organization must collect the Bio-Medical Waste from the DHH/SDH/CHC/PHC & other peripheral Govt. Hospitals in a specified container. For this purpose, the respective Hospitals in Charge need to sign a MOU with OS Agency and CDM&PHO of the Bargarh district regarding the requisite fee as finalised in the above tender process.
    - c. The requisite out sourcing charges as per finalisation of rate contract will be paid by the concerned CDM&PHO or DMO (MS)-cum-Superintendent, DHH or superintendent SDH or CHC as per district BMWM Committee decision.
    - d. For collection of Bio- Medical Wastes from DHH/SDH/CHC/PHC, it should be kept in mind to minimise the k.m. i.e. the route map should be justified in such a way that it covers maximum to maximum health institutions in one route during travel of the transporting vehicle for Bio-Medical Waste.
  23. It is the responsibility of agency to provide the bio degradable colour coded waste bags & other consumables to all bedded hospitals. However the Health Institutions has to ensure placing of colour coded container/bins with bio hazard symbol at the generation points in the hospitals.
  24. The out sourcing agency will ensure to provide all personal protective gears & immunise its workmen for handling of BMW such as - Apron, Gumboot, Mask, Cap, Goggles, Rubber Utility Gloves and Hepatitis B, TT Injection as per requirement.
  25. The BMW equipment such as Autoclave & Shredder located at SDH Padampur will be utilised by the OS agency for treatment of wastes of nearby CHCs/PHCs. Minor repairs & regular maintenance will be made in consultation with the supplier firm while the electric charges will be borne by the agency. A separate register for registering the complains regarding the BMWM Equipment may be maintained by the OS agency.
  26. The outsourcing Agency shall maintain all the records related to Bio-Medical Waste Management of all the units. Daily records shall be maintained for the waste accepted and treated waste removed from the site. This record shall include the following minimum details.
    - a. Waste accepted:- waste collection date, name of the generation point, waste category as per the rules, quantity of the waste, vehicle number and receiving date (at site).
    - b. Treated waste removed: - Date, treated waste type, quantity, vehicle number and location of disposal.

- c. Log Book: A log book shall be maintained for each BMWM equipment installed at the site and shall include the following:
    - i. The weight of each batch of waste treated.
    - ii. The categories of waste as per the rules.
    - iii. The time, date and duration of each treatment cycle and total hours of operation.
    - iv. The complete details of all operational parameters during each cycle.
    - v. Accident reporting Register is to be developed and maintained.
  - d. Site Records: Site records shall include the following:
    - i. Details of construction or engineering works of the pits.
    - ii. Maintenance schedule, breakdowns/trouble shootings and remedial action.
    - iii. Emergencies.
    - iv. Incidents of unacceptable waste received and the action taken thereof.
    - v. Details of site inspections by the officials of the regulatory agency and necessary action on the observations.
    - vi. Daily, monthly and annual summery records of all the above shall be maintained and made available at the site for inspection whenever required by inspecting Officer.
27. Manpower engaged by the out sourcing agency should not claim any type of compensation/ absorption/ regularisation/ benefit (Health Related also) of service from the office of the CDM&PHO, Bargarh under any circumstance.
  28. The Manpower of the outsourcing agency should not consume alcohol, betel, smoking during the duty hour nor be involved in any type of criminal activities.
  29. The DHH/SDH/CHC will maintain attendance register of the staff engaged by the OS Agency. The agency will have to prepare duty list & submit to the office as mentioned above by date 25<sup>th</sup> for the next calendar month. Absence from duty is not allowed at any cost. However under unavoidable circumstances, the agency should have to make alternative arrangements with due approval by the concerned Authority.
  30. After the allotment of the work, the said Agency/Organisation shall have to sign a MOU with the concerned authority (DMO-cum- Superintendent for DHH & CHC, Bargarh, Superintendent for SDH, Padampur & concerned BPHO/MO I/C for respective CHCs/PHCs) regarding the detail scope of services to be executed.
  31. The said contract will work initially for a period of one year from the date of agreement that will be renewed/extended on yearly basis up to maximum of total three years, if found satisfactory by the Competent Authority and Bio Medical Waste Management Committee, Bargarh. During this period if at any stage of time, the Hospital Authority finds non-compliance of the assigned work, the said OS agency will be served with a notice for a period of one month and if still non-compliance is there, the said contract will be cancelled and new party will be assigned with the said service as decided by the Competent Authority and Bio Medical Waste Management Committee, Bargarh.
  32. After allotment of the order, the Outsourcing agency shall execute the service within 15 days of the issue of letter.
  33. The Outsourcing agency/Organization has to sign a Memorandum of Understanding (MOU) with the concerned Authority (CDM&PHO/DMO cum Superintendent DHH/Superintendent SDH/BPHO/MO I/C for respective CHCs/PHCs) on the day of execution of the work orders.
  34. The final monthly bill in triplicate to be submitted along with the consolidated monthly report to CDM&PHO/DMO cum Superintendent DHH/Superintendent SDH/BPHO/MO I/C for respective CHCs/PHCs (who ever have signed MOU with the OS agency) on 1<sup>st</sup> week of each month.

35. Besides, the Outsourcing agency has to submit Monthly Progress Report/Status report duly signed by the Hospital Manager / Junior Hospital manager/ Block Programme Manager / Matron/Staff Nurse/ Pharmacist with remarks to the superintendent DHH/SDH/CHC/CDM&PHO, as the case may be without fail. Three consecutive Adverse Remarks may be treated towards cancellation of the Contract.
36. The Outsourcing Agency shall be under the Administrative Control of the CDM&PHO/DMO cum Superintendent DHH/Superintendent SDH/CHC and the work will be supervised by the Hospital Managers/ Junior Hospital Manager/BPM/ Matron/ SN/ Pharmacist.
37. All the legal disputes are subject to the jurisdiction of the District Court only.
38. The number of workers to be engaged by the Outsourcing Agency will be specified institution wise and may be modified with the revision/further increase in bed strength. Details of Health Care Institutions with functional bed strength are mentioned below.
39. Payment for Collection & transportation & disposal for SDH, all CHCs (except CHC, Bargarh) & PHCs will be made centrally at Office of CDM&PHO, Bargarh on submission of necessary bills & satisfactory performance certificates from concerned superintendent/BPHO/MO /C. However, Payment for the same for DHH & CHC, Bargarh will be made by DMO (MS) cum Superintendent DHH, Bargarh on submission of necessary bills & satisfactory performance certificates.

## PENALTY

40. In case of deficiencies in providing quality service, the authority i.e. CDM&PHO, Bargarh will have the right to impose penalty as per decision of the BMW Committee which shall be deducted from the monthly bill.

## FINANCIAL

41. The Technical Bid should be accompanied with an Earnest Money deposit (EMD), refundable without interest, of **Rs.30,000/-** only in the form of Demand Draft drawn in favour of **Bio Medical Waste Management of Bargarh Dist**, payable at Bargarh failing which the tender shall be rejected out rightly.
42. The Earnest Money Deposit in respect of the agencies which do not qualify the Technical Bid (First competitive Stage) / Financial Bid (Second competitive stage) shall be returned to them without any interest. In case of successful tenderer if the agency fails to initiate service and deploy the required manpower against the initial requirement within 30 days from date of placing the order the EMD shall stand forfeited without giving any further notice.
43. The successful tenderer will have to deposit a Security amount of Rs.1,50,000/- (Rupees One Lakh Fifty Thousand only) in the form of Fixed Deposit Receipt/Bank Guarantee (Auto renewable) made in the name of the Agency and hypothecated to **Bio Medical waste Management of Bargarh Dist under Zilla Swasthya Samiti, Bargarh** covering the period of contract, which will be refunded without interest in case of completion /cancellation of the contract
