PRE-QUALIFICATIONS FOR QUOTATION OF CHEMICALS, REAGENTS AND INSTRUMENTS:-

1. The participating bidder should be a reputed Pharmacies/ Wholesaler/Dealers/ Distributers dealing with chemicals, reagents and instruments
2. The participating bidder who has been blacklisted by State and Central Govt. or any PSU will not be eligible to participate in this quotation process.

TERMS & CONDITIONS OF QUOTATION:-

1. Quotation papers should be typewritten without any correction of overwriting & each page of quotation paper should be numbered.
2. Supply should be made at the O/o Chief District Veterinary Officer, Bargarh within 7 days after receiving supply order.
3. The bidder should have a valid license and GSTIN Registration.
4. The bidder should enclosed self-attested copy of PAN, GSTIN Registration Certificate & GSTIN clearance for last quarter.
5. The bidder shall quote any one of the item intended to supply from the list of chemicals, reagents and instruments as enclosed in annexure B.
6. The tax will be charged as per Govt. guidelines.
7. Payment shall be made after delivery of items in proper conditions and specification through RTGS after submission of Bills/Vouchers. The bank details of the bidders should be mentioned on the body of bill.
