



SHORT QUOTATION CALL NOTICE


Sealed Quotations in plain papers are invited from the local bonafide suppliers/manufactures/agency/Firms/Co-operatives for installation of Fire Alarm at the District EVM Warehouse, near Collectorate, Bargarh for security and safety of EVMs and VVPATs as per the following terms and conditions. The sealed quotation paper should be dropped into the Tender box meant for the purpose kept in the office chamber of the District Election Officer, Bargarh by **14.08.2023 till 4.00 PM** during the office hours which will be opened on the same day i.e. **14.08.2023 at 5.00 PM** in the office chamber of the Addl. District Magistrate, Bargarh in presence of the members of Purchase Committee and the bidders or their authorized representatives. Quotations received after the stipulated time shall not be accepted.

- 1 Up to date GST/IT clearance should be furnished along with Quotation papers without which the Quotation will not be taken in to consideration.
- 2 The bidder shall produce sample of the article for **Fire Alarm** to be supplied before the Committee at the time of opening of the quotations with in the price of Rs. 30484/- (Rupees Thirty Thousand Four Hundred Eighty Four) only.
- 3 The Bidder will be required to supply the article with in three days from the date of receipt of the supply order.
- 4 The price quoted in the Quotation shall include all taxes, transportation charges etc. The delivery of articles shall be made in the District Election Office, Bargarh.
- 5 The Collector & District Magistrate , Bargarh reserves the right to reject any/all tenders without giving any reason thereof. She also reserves the right to change the quantity of materials . The decision of the collector & District Magistrate, Bargarh shall be final.
- 6 The firm /Person whose tender will be accepted shall have to execute an agreement with the District Election Officer, Bargarh in Non-Judicial stamp paper worth of Rs 10/- only on the prescribed terms within one day . from the date of acceptance of the quotation and supply order will be issued only after the said agreement is executed.


