Tender Call Notice for Bid Identification No. 02/2023-24 dated 09.08.2023

1. The Executive Engineer, Megalift Projects Division, Sambalpur invites item rate bids in sealed cover in conformity with, detailed Tender Call Notice to be eventually drawn in State PWD form **P1 contract** for the execution of works detailed in the table below from eligible Class Contractors registered with the State Government for execution of civil works, registered firms having experience of survey works, on production definite proof from the appropriate authority. Bidders registered with other State Govt./ MES / Railways/ CPWD in the equivalent rank may participate in the tender for the works in the State. But successful bidder has to register under the State PWD before signing of the agreement. The bidders may submit bids for any or all of the following works.

2. The sale and receipt of the Bid documents shall start from **10 AM** on **09.08.2023** and close on **17.08.2023** at **05.30 PM**. The Bids will be opened on the same day at **06.00 PM** in the office of the undersigned in the presence of the bidders of his authorized agent/representative only who wish to attend. If any schedules last date happens to be a holiday, next working day will be the last date for that schedule venue and time.
3. Bids must be delivered in the Tender box having Bid Identification No. **02/2023-24**. Bids deliver in the wrong box shall not be taken into consideration.
4. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500/- over the cost documents or non-receipt of the same.
5. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers.
6. Other details can be seen in the bidding document.
7. Bidding documents can be purchased from the office of the undersigned against a non-refundable fee towards cost of the documents in the form of cash or demand draft issue from any scheduled bank payable at Sambalpur in favour of the Executive Engineer, Megalift Projects Division, Sambalpur.
8. Bid must be accompanied with EMD 1% for the work specified will have to be in any one of forms as specify in the bidding document. Shortage of EMD shall be considered as non-responsive & will be liable for rejection.
9. The bidder shall furnish an affidavit at time of submission of the bid, about the authentication of the tender documents including valid registration certificate, PAN card, GST certificate, Work Experience Certificate (Ayacut Survey Work) and security etc. duly attested by Gazetted Officer, failing which the bid shall be consider as non-responsive and thus liable for rejection.

10. Bidders are not required to write their name on the outer cover containing the bid documents. They are only required to write the name of the work and authority who had issued the tender.
11. Engineering Contractor desirous to avail exemption of EMD shall have to enclose an affidavit for not having availed this facility in three works during the year 2023-24.
12. No grace is allowed to SC/ST license unless claimed.
13. The bid of successful bidder can be considered as non-responsive in case of failure of the completion of any previous work by him or bad performance record and the authority in this case is not bound to award the work.
14. If the bid is less than 15% of the tendered amount then such a bid shall be rejected.
15. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
