Tender Call Notice No. 3147

Sealed tender in plain paper are invited from the local bonafide Proprietor Agency/Firm/Industry/Individual for supply of GPS device with tracker for use in the ensuing Simultaneous General Elections to Lok Sabha and OLA, 2024. The details scope of the work and technical specification (Annexure-A) is available in the district website i.e. bargarh.nic.in. The sealed tender paper should be sent through RP or dropped into the Tender box meant for the purpose kept in the office of the undersigned during the office hours by **2.00 PM of Dt. 05.03.2024** which will be opened on the same day i.e. on **at 4.00 PM** in my office chamber in presence of the members of Purchase Committee and the tenderers or their authorized representatives. Tenders received after the stipulated time shall not be accepted.

Term and Condition

1. Each tenderer is required to deposit earnest money of Rs 10,000/- (Rupees Ten Thousand) only in shape of demand draft payable to District Election Officer, Bargarh at the Main Branch of State Bank of India, Bargarh. Tenders without earnest money deposit will be summarily rejected .The earnest money of the unsuccessful bidders will be refunded on the day of finalization of the tenderer
2. The Firm must be an authorized firm of the manufacturer and the quotation must enclose the photo copy of authorization.
3. Up to date GST / Income Tax clearance should be furnished along with tender papers without which the tender will not be taken into consideration.
4. The earnest money will be released only after satisfactory performance of the selected firm/individual of the Proprietors.
5. There should be provision of displaying the vehicles locations at least 20 locations for tracking the movement of the vehicle through computer/mobile device
6. The Rates should be inclusive of installation charges.
7. The GPS device should have provision of display of running status, KM Travelled with back up of atleast 6 months, display of exact location, display of idle/start, totally stop and running status of the vehicle.

validity of SIMs must be 6 months. Any other applications suitable for the purpose shall also be taken into consideration.

9. In case of failure to supply GPS Tracker as per the direction of the concerned authority and providing quality recording and timely performance in full as per the specification within the stipulated period the security deposit of the selected firm/individual will be forfeited.

10. The price quoted in the tender will include all tax, transportation charges. The bidder is to render service at the places to be decided by the authorities of District Election Office, Bargarh.


11. The Collector & District Election Officer, Bargarh reserves the right to reject any/all tenders without giving any reason thereof and modify the technical specification without assigning any reason thereof. The decision of the Collector & District Election Officer, Bargarh will be final.

12. The Firms /Persons whose tender will be accepted shall have to execute an agreement with the District Election Officer, Bargarh in Non-Judicial stamp paper worth of Rs 10/- only in respect of prescribed terms and conditions within two days from the date of acceptance of the tender and the order will be issued only after the said agreement is executed. The selected firm/agency/bidder must deploy some technical staff to ensure the functionality of the devices.

13. In view of Election urgency and immediate service, the firms located in the district of Bargarh shall be given preference. The selected firm/agency/bidder should be ready to extend required service relating to fittings, replacement etc as and when required

14. The specification of GPS with vehicle tracking device and its rate is to be quoted as per Annexure - A


14. Payment will be made, on successful completion of the work, after receipt of invoice/ bills.






