TERMS AND CONDITIONS FOR SUPPLY OF BS6 AC AMBULANCE UNDER CDM & PHO, BARGARH.

- 1.** The bidders may download the tender documents directly from the www.bargarh.nic.in. The bidders are required to submit tender document fees of **Rs.2000/- (Rupees two thousand)** only non-refundable, **in shape of Demand Draft in favour of ZSS, Non-NRHM Funds Bargarh** with tender documents.
- 2.** The bidders are required to submit Earnest Money Deposit of **Rs. 32,000/- (Rupees thirty-two thousand)** only (refundable) in shape of Demand Draft in favour of ZSS, Non-NRHM fund, Bargarh. If the bidder qualified in technical bid, then EMD will be converted to performance security which will be returned after One Year and if the bidder is not qualified in technical bid the EMD will be refunded within seven days from the date of finalization of tender.
- 3.** The tender paper will liable to be rejected if the bidder changes any clause of the terms and condition bid documents.
- 4.** Sealed bids documents should reach to the office of the CDM & PHO, Bargarh on or before **Dt. 04-04-2024, up to 4 P.M.** Any tender paper received after the due date and time will be rejected/returned to the sender unopened. The tender paper will be received through Speed Post/ Regd. Post/ Courier Only.
- 5.** The CDM & PHO shall have no responsibility for any delay / Omission on part of the bidder and reserves the right to reject any or all bid documents without assigning any reason thereof.
- 6.** The bidder(s) are to submit their bid documents in separate sealed covered envelops for Technical Bid and Price Bid by super-scribing **Cover 'A' (Technical Bid)** and **Cover 'B' (Price Bid)** & both the sealed covers envelop should put into a third outer cover envelope which should be super-scribed as **"Tender for Supply of BLS BS6 AC Ambulance, Type-B" and Tender Reference Number-66/NHM/BARGARH/2023-24/Dt.12-03-2024"**.
- 7.** The sealed bid documents will be opened in the presence of the members of Purchase committee and the bidder or their duly authorized representatives. In case the Scheduled date is declared Holiday the tenders shall be opened on next working day.
- 8.** The rate quoted by the bidder should be inclusive of all taxes (GST/ Freight/ Insurance etc) and should not exceed maximum retail price.
- 9.** Conditional bids are liable to be rejected. The decision of Purchase Committee will be final. The bids which are not as per the specifications will not be considered.
- 10.** The authority will not make any advance payment to the organization. The organization will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.
- 11.** Supplier has to supply the items within 30 days as per the order placed and in the rate approved to the office of the CDM & PHO, Bargarh as and supplier shall submit the bill for payment

at the approved rate in respect to quantity of items supplied. The transportation of items is sole responsibility of the supplier and must deliver the item on door delivery basis.

12. The authority will not make any advance payment to the bidder. The bidder will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.

13. Violating the tender terms and conditions will disqualify the firm to participate in the tender for a period of 2 (two) years from the date of issue of letter and his E.M.D will be forfeited.

14. Rates quoted shall remain valid for a period of one year from the date of finalization of the tender.

15. Price bid of the items must be accompanied with soft copy.

16. If there is any typographical error in the tender documents the decision of CDM &PHO, Bargarh is final.

17. The Institute reserves the right to accept in part or in full or reject any or more Tender / offer without assigning any reasons or cancel the tendering process and reject all Tender at any time prior to award of contract, without accepting any liability, whatsoever.
