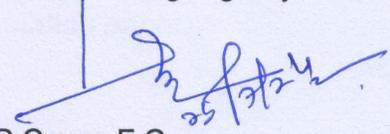

The quotation must quote their rate item wise inclusive of all taxes and delivery charges of the materials at Bargarh.

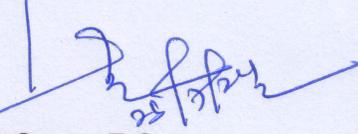
