- The bidders should quote their best competitive rate. The bidders have to submit the auction application papers along with required EMD in the form of Demand Draft in favor of **"Farm Superintendent, Lachida Farm"** and **"Farm In charge Chakuli Farm"** payable at SBI, Attabira Branch.
  
- The auction will be in two parts i.e. Technical Bid (Form-A) and Financial Bid (Form-B). The bidders should submit their Technical and Financial Bid separately in two envelopes and should be put into another cover super scribed as **"AUCTION SALE OF PADDY/GROUNDNUT NON-SEEDS. 2024-25"**. All the envelopes should be addressed to the **"Farm Superintendent, Lachida Farm"** and **"Farm In charge Chakuli Farm"** should contain the name and address, Mobile No. of bidder. The auction applications are to be received through Registered **Post/Speed Post/Personal messenger**.
- Bidders who qualify technically. their financial bid shall only be opened.
- The undersigned reserves all the rights to accept/reject any or all the tender(s) without assigning any reason thereof.

## TERMS AND CONDITIONS

1. The auction application should accompany with EMD 20000/- (Rupees Twenty thousand) only for Paddy and EMD 2000/- (Rupees Two thousand) only for non-Paddy.
2. The EMD to be deposited in the form of **Demand Draft** in favour of "**Farm Superintendent, Lachida Farm**" and "**Farm In charge Chakuli Farm**" payable at SBI, Attabira Branch, along with the application. Submission of EMD in any other form will not be accepted and the tender will be summarily rejected. In case of successful bidder, the EMD may be converted towards part of security amount on request.
3. The Original Demand Draft towards EMD must be submitted with the technical bid.
4. The EMD of unsuccessful bidders will be returned within 30 days from the date of finalization of the decision of the Auction Committee. The EMD shall not carry any interest.
5. The successful bidders (s) (H-1) shall deposit 10% of the bid amount within 7days on receipt of the order though Bank Transfer in favour of "**Farm Superintendent, Lachida Farm**" and "**Farm In charge Chakuli Farm**" as Security Amount and submit an undertaking for lifting of the stock within the scheduled time. If the tenderer (s) fails to deposit the 10% bid amount within the stipulated time, the EMD deposited along-with the application will be forfeited without any further communication. The Security Deposits shall not carry any interest.
6. **In case the successful tenderer (s) fail to lift the stocks in stipulated time, the CDAO, Bargarh reserves all the right to forfeit the Security Amount.**
7. The Farm Superintendent, Lachida Farm staff members or their relatives are not allowed to participate in the auction process directly or indirectly.
8. The defaulting firms who have been black listed/deported to deal with the business activities of Farm Superintendent, Lachida Farm and Farm incharge Chakuli Farm is/are not eligible to take part in the auction process.
9. The total stocks can be inspected between 8.00 A.M to 1.00 P.M. in all working days at Govt Agriculture Farm, Lachida and Chakuli where the stocks proposed for auction sale are available.
10. Quantities mentioned in the auction schedule are as per the report of Farm Superintendent, Lachida, Farm and Farm Incharge Chakuli. The quantity may be slightly lower than the quantity mentioned due to storage loss.
11. (i) The entire stock has to be lifted within 30 days from the date of submission of undertaking from the stocking point failing which the security deposit i.e. 10% of bid amount deposited by the successful bidders shall be forfeited.  
(ii) The security amount equal to 10% of the bid amount deposited by the bidder(s) would be returned to the bidder after completion of transaction/will be adjusted towards the cost of non-seeds on request by the bidder.  
(iii) The acceptance of further deposit of non-seeds cost may be considered for a period of another 30 days on mutual consent subject to payment of Godown rent @ Rs.10/- per quintals per month and extra penal interest @ 2% more than the rate at which SBI pays interest for fixed deposit per annum for the extended period for the cost of the non-lifted quantities by the tenderer.

- (iv) If the tenderer fails to lift the stock even after the extended period of 30 days the entire security deposit shall be forfeited without any further notice.
- (v) Further godown rent shall be charged extra for the delayed period of lifting of the stock for which the cost has been deposited earlier if any. In such cases lifting order shall be allowed for such value after deducting the godown rent.
12. The stock is to be lifted "as is where is basis **"at godown of Lachida and Chakuli Farm"**. Seed material is packed in OSSC, Ltd. bags will be delivered as is where is basis directly after defacing of printed details on bags and removal of tags, labels etc. by the party at his own cost and the same shall be deposited to the godown In-charge. The successful bidder will have to make their own arrangement for lifting of the stock within the stipulated time at their own cost.
13. **The bidder(s) must check thoroughly the quality of the stocks before submission of the auction application.**
14. Any Tax leviable shall be borne by the bidder.
15. **In case the bid application is accepted, the bidder will have to submit an Affidavit stating that the stocks will not be used for seed purpose.**
16. The bids should be submitted only after agreeing all the above terms and conditions and conditional tenders will be rejected.
17. The stock would be weighed along with HDPE bags and the rate offered per quintal would be inclusive of bags in which the non-seeds are packed. Electronics weighment slip must be generated and attached with the challans with due countersignature of Farm Superintendent Lachida & Farm In charge Chakuli Farm for delivery of the stock Otherwise no loss of weight shall be allowed.
18. **The cost of non-seeds per quintal should be quoted by the bidder.**
19. All charges of transport, weighment, loading, unloading and labour charges etc would be borne by the bidder.
20. The qualified bidder shall credit the amount in **Farm Superintendent Lachida Farm** (Bank Account NO. 10777584293 of state Bank of India, Attabira, Bargarh and IFSC code is SBIN0002004) and **Farm incharge Chakuli Farm** (Bank Account NO. 32374855045 of state Bank of India, Attabira, Bargarh and IFSC code is SBIN0002004 for the cost of non-seeds basing on which the lifting order shall be issued in the name of the bidder with a suitable advice to Farm In Charge for necessary arrangement for delivery of non-seeds from Lachida/ Chakuli Farm.
21. **FRAUD & CORRUPTION:** a) The bidders shall observe the highest standard of ethics during bidding and during completion of the auction process. For the purpose of this provision, the following acts shall be considered as corrupt and /or fraudulent practices. "Corrupt Practice" means offering, giving receiving or soliciting directly or indirectly, of anything of value to influence the action to an official in the auction process.
- b) "Fraudulent Practice" means misrepresentation or omission of facts during the auction process.

- c) "Collusive Practice" means a scheme of arrangement between two or more bidders, with or without the knowledge of the purchaser, designed to establish bid prices at artificial, non-competitive level.
- d) "Coercive Practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the auction process. During the process of evaluation of a bid or proposal, if it is detected that a bidder directly or through agent has engaged in corrupt, fraudulent, collusive or coercive practice, then
- i) The bid shall be rejected and
  - ii) Declare the firm ineligible for a specific period or indefinitely to participate in a bidding process. However, if any such practice is detected at any subsequent stage or during execution of the process, the Authority will exercise the right to cancel the lifting order and make suitable alternative arrangement at the risk and cost of such offending bidder.
  - iii) An undertaking in this regard shall be given by the participating bidder as at Annexure-I failing which the application shall be rejected.
22. The bidders submitting application must super scribe in bold letters "**AUCTION SALE OF PADDY/ G.NUT NON-SEEDS, 2024-25**" on the top of the sealed cover in which Tender is sent.
23. The bidder must submit the **self-attested copy of GST Registration Certificate from the competent authority. The Registration Certificate should contain the non-seed items for which the firm offered rate.**
24. **The intending bidder should submit self-attested copy of PAN Card.**
25. All disputes, controversies or claims arising out of or in connection with or in relation to this contract, of its negotiation, performance, breach, existence or validity, whether contractual or tortuous, shall be resolved by the Parties on mutual consent. In such cases the ruling of the CDAO, Bargarh will be the final and binding to all the parties.
26. **The EMD must be submitted with the Technical bid.**
27. The CDAO, Bargarh may call the bidders for production of the original documents at the time of verification of the technical bid documents submitted by the bidders. The CDAO, Bargarh is also empowered to make negotiations with the qualified H-1 bidder to fetch highest rate for auction of the Mustard & Paddy non-seeds.
28. The entire quantity is to be lifted by the bidder within the stipulated time period i.e. 30 days from the complying procedural formalities.
29. **The order of the CDAO, Bargarh will be final in case of any dispute and neither party shall file proceedings in any Court.**
30. **The CDAO, Bargarh reserves all the rights to accept / reject any or all bidders without assigning any reason thereof.**
