Expression of Interest (Eol) is invited by the Chief District Agriculture Officer, Bargarh from intending bidders/ reputed firms for supply of display board different Demonstrations under State Plan Scheme "Comprehensive Rice Fallow Management Project" (CRFM) during Rabi 2024-25. The Eol document must be submitted by Register Post/Speed Post/Courier Service during the working hour latest by 31.01.2025 up to 3 PM. & the Eol will be opened on the same day at 4.00PM in the office chamber of the Chief District Agriculture Officer, Bargarh. The undersigned reserves the right of rejection (Any/all) without any reason thereof.

List of Document to be submitted: -

- (1) Self certificate stating that the agency has not been blacklisted in the past.
- (2) Average annual turnover of 3 consecutive year must be 10 lakhs or above. (The related documents are to be furnished)
- (3) Applicant agency must furnish a copy of their GSTIN registration certificate and clearance up to March 2024.
- (4) Agency need to submit the copies of IT return for last 3 financial year.
- (5) Agency must have supplied display board for at least 10 similar agricultural assignments under Department of Agriculture, Odisha during the last three consecutive financial years. (Copies of work order).
- (6) Quoted price should be clearly mentioned in the bid & should be inclusive of tax both for supply of display boards at block points.
- (7) The Display Board with size 4'X3' fitted with hollow iron frame @ 1 number per demonstration cluster/ per 20 hectare should be fixed at demonstration plot before preparing the documentary film. The total programmed area is 13000 Ha. covering in all 12 blocks in Bargarh District.
- (7) Payment to the agency on the assignment will be made by assigning authority/ office, for the deliverables submitted by the agency. Payment will be made as per Government of Odisha norms after successful completion of the assignment.

(8) The Authority reserves the right to accept or reject any or all quotation without assigning reasons thereof. Besides the Quotations received in incomplete form/ after due date will be taken as rejected.

N.B: The agreement shall commence from date of signing and shall continue till completion of said project unless it is curtailed or terminated by the authority owing to deficiency of service, substandard quality of performance, breach of contract etc. or change in requirements. As the programme is season specific, even if a single bidder applies then it may qualify for consideration on fulfilling selection criteria.
