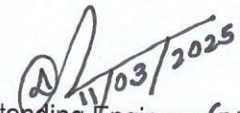

1. The Service provider shall have a valid OGST registration to participate in the tendering.
2. The Service provider, participating in the bidding process under the jurisdiction of Municipal Corporation, shall be registered on GeM Platform.
3. The Vehicle must be in road worthy condition, shall not be more than **3 years old** from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. mandatory for plying of vehicle.
4. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/ passenger vehicle.
5. The Driver should be well behaved, gentle and obedient in nature.

6. A sum of ₹ 5,000 /- Shall be deposited by the intending bidders in shape of Deposit Receipt from Nationalised Bank/ NSC/ KVP duly pledged in favour of Superintending Engineer, Gangadhar Meher Lift Irrigation Project Division No. II, Bargarh and submitted along with the tender as security deposit. Terms & Conditions

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid registration Certificate, Insurance Certificate, Pollution Certificate, Fitness certificate, valid Contract carriage permit, proof of up-to-date tax payment etc, and D.L. of the driver available all the times which are mandatory for plying of vehicle. Perfernce will be given to new/ latest with BS-VI emission compliant vehicle.
2. The Departments / Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
3. The service providers will ensure that the vehicle is kept under optimum running condition and avoid accidents attributable to lack of maintenance/ upkeep. The hired vehicle cannot be used for any private/ commercial purpose beyond office hours or during holidays.
4. The hire charges to be paid for monthly basis if final but does not include cost of fuel, which is to be paid separately basing on actual consumption and as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & differential coolant, Tyres & Tubes, Battery etc. will be borne by the Bidder.
5. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the owner.
6. The Driver should be well behaved, gentle and obedient in nature. He should be neatly dressed in proper uniform and should maintain all protocol while in duty. He should have specific Mobile number to attend the calls round the clock if required. No separate payment shall be made for the same.
7. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder
8. In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
9. The vehicles shall report for duty for minimum of 25 days in a month.
10. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
11. Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per Govt. Norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider subject to availability of fund and no advance payment will be made.

12. The hiring may be discontinued immediately, when the vehicle is no longer required for office.
13. The Vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
14. The selected/ successful bidder will have to execute an Agreement with the Authority as per Government in F.D.O.M No- 22924/F, date 14.08.2023.
15. The period of contract can be extended subject to satisfactory performance.
16. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
17. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
18. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
