

The tender paper should reach to the office of the undersigned through registered post/speed post/courier on or before 17.03.2025 by 5:00PM and the same shall be opened on 17.03.2024 at 5:00PM in the presence of the quotationer or their authorized representatives.

The bidder must quote their rate item wise inclusive of all taxes and delivery charges of the materials at Bargarh.



Terms & Conditions

1. The bidders are required to deposit Rs. 1180/- Including GST @ 18% (**Rupees One Thousand One Hundred Eighty only**) towards cost of tender paper (non-refundable) in shape of Demand Draft / Pay Order in favour of "DSMS, Bargarh" payable at Bargarh and attached along with the tender paper to be downloaded from the website.
2. The bidders are required to deposit the E.M.D of Rs.30,000/- (Rupees Thirty Thousand only) in shape of Bank draft / Pay Order in favour of "DSMS, Bargarh" from any Nationalized Bank. The E.M.D. of the successful bidder will be kept with DSMS till the supply of the materials. In case of any unsatisfactory work, delay supply of materials etc. the E.M.D will be forfeited as per the decisions of the authority. Tender papers without E.M.D shall not be accepted.
3. The bidders should quote the rate of machinery inclusive labour, transport & other charges.
4. The bidders have to quote the rate of each item per unit exclusive tax separately.
5. The bidders should be registered from CGST & SGST authority and should furnish GST, PAN & valid license.
6. The supplier of Machinery / Equipment's should provide both theoretical and practical training after commissioning the machinery or at appropriate stage.
7. Delivery of the Equipment's / Machineries shall be done within 15 days of receipt of the purchase order.
8. The bidders have to submit valid Authorization certificate from the manufacturer / Dealer / distributor for the item quoted. Also, Manufacturer must be having CE certificate, IP-54 grade certificate and ISO certification and having 3 installations of same type machine across Odisha.
9. The bidders have to produce proof of successful execution of similar nature of work and submit at least 2 nos of purchase order copy of govt. agencies across Odisha
10. Quotation complete in all respect should reach before the C.D.O-cum-E.O, Zilla Parishad, Bargarh
11. The quotation will be opened on dt. 17.03.2023 at 5.00PM In the office chamber of the C.D.O-cum-E.O, Zilla Parishad, Bargarh by the purchase committee in presence of the quotationer or their authorized representative.
12. The equipment / Machinery & accessorizes should be delivered, installed and commissioned at the address specified in the order. Service / operation / instruction / manuals (In English) tool kit must also be supplied along with the machinery and accessories.
13. The authority reserves all the right to reject or any of the Tender / quotation without assigning any reason thereof.
14. Any non-fulfillment of the above noted terms will make the bid invalid.
15. The bidders should have service point located within Bargarh. The bidder should submit the details of Local service point.
16. The tender must be delivered at the specified address as per the Bidder Data Sheet by Speed post / Registered Post/Courier only. The Client shall not be responsible for postal delay or any consequence. Submission of proposal through any other mode will be rejected.
17. Bidders should submit the supporting documents as mentioned. Bids of agencies not conforming to the eligibility criteria listed in the tender document will be summarily rejected. Submission of forged documents will also result in rejection of the bid.
18. The bidder should submit the tender paper with two envelopes i.e. Technical Bid and Financial Bid separately.

19. The bidders have to offer the price for all items or else the tender paper will not be considered.
20. There must be warranty coverage of all machinery's minimum of 1 Year from the date of installation.
21. Payment shall be made after installation of machineries and hands-on training.
- 22. While submitting the tender, the tenderers should submit the followings documents :**
- Copy of work orders/ experience certificate for similar nature of works for last 1 year.
 - Authentic proof of ownership of printing firm/authorized dealer/supplier.
 - Registration certificate of Goods & Services Tax (GST).**
 - Copy of the PAN**
 - Copy of GST return/amount deposit in the last financial year and copy of last deposit challan.
 - EMD of Rs. 30,000/- in favor of DSMS, Bargarh in shape of Demand draft/pay order.
 - Average Annual Financial Turnover during the last three years, ending 31st March of the previous financial year, should be at least Rs. 1,00,00,000/- for which the audited financial statement to be attached.
 - Income Tax return for the last year i.e. 2023-24.
23. TDS applicable will be deducted from the bill amount submitted and will be deposited under concerned head of account.
24. The bidder should submit the price list of all items as per specification.
25. The bidder or the representative of the bidder should attend the opening event of the tender with all original documents /papers for verification, if required.
