- i. Transportation of Rice from F.C.I. godowns i.e. OSWC Attabira, Kendupali, Godbhaga, Nagenpali 01, Nagenpali 02, CWC Kendupali, CWC Bargarh, FSD Attabira, PEG Gaudpali & RRC Mahulpali to different Anganwadi Centers of the concerned block of Bargarh District .
- ii. Transportation of Wheat from FCI, Depot. to different THR units of the district.

The tender paper with detail terms and condition of tender shall be downloaded from the Bargarh District web site [www.bargarh.odisha.gov.in](http://www.bargarh.odisha.gov.in). 

- b. Envelope containing the Price Bid shall be sealed and subscribed as- '**PRICE BID**' FOR ENGAGEMENT OF TRANSPORT CONTRACTOR FOR TRANSPORTATION OF RICE/ WHEAT UNDER SNP PROGRAMME FOR THE YEAR 2025-26.
- c. The big sized envelope containing the Technical and Price Bid shall be subscribed as- **TENDER BID FOR ENGAGEMENT OF TRANSPORT CONTRACTOR UNDER SNP PROGRAMME OF BARGARH DISTRICT FOR THE YEAR 2025-26**

1. Sealed Tender in prescribed forms are invited from the intending registered transport Contractors /Agents/companies/ Individuals for undertaking Transportation of Rice from OSWC i.e. OSWC Attabira, Kendupali, Godbhaga, Nagenpali 01, Nagenpali 02, CWC Kendupali, CWC Bargarh, FSD Attabira, PEG Gaudpali & RRC Mahulpali to different AWC Point / Wheat from FCI, Depo to different THR Unit points under SNP feeding programme for the year 2025-26 in Bargarh District.
2. The tender paper with detail terms and condition of tender shall be downloaded from the Bargarh District web site [www.bargarh.odisha.gov.in](http://www.bargarh.odisha.gov.in). The cost of the Rs. 5000/- (Rupees Five Thousand only) be deposited in favour of DSWO, Bargarh through any nationalized Bank and must be submitted along with the tender document towards cost of the tender paper in Demand Draft/ Bank Draft.
3. The tender papers shall reach to the office of the DSWO, Bargarh the undersigned on or before Dtd.29.05.2025 up to 1.00 PM through (speed post / Registered post) The sealed tenders will be opened on date.30.05.2025 at 11.00 AM in presence of the members of tender committee and tenderers or their authorized representatives (only one member). The tenders papers received beyond the scheduled date and time shall be rejected. Details regarding tender papers, terms & conditions can be downloaded from the Bargarh District website [www.bargarh.odisha.gov.in](http://www.bargarh.odisha.gov.in). The tender documents sent other than the above mode shall not be entertained in any circumstances.
4. The successful tenderers will lift the rice and wheat from above godown and unit F.C.I Godown and make delivery of the same at all the AWC points & THR Unit SHG points of the Dist as per instruction of the Collector/D.S.W.O. from time to time under SNP feeding programme for the year 2025-26.
5. Transportation charges of rice & Wheat from OSWC, Bargarh and F.C.I. Godown to all AWC Points / WSHG points respectively within ceiling price of Rs.150/- per Qtl. as per Govt. order including loading & unloading and other incidental charges irrespective of distance.

6. The tender paper should be filled up properly without any correction / over writing. The rate and unit should be written both in words and figures in tender. The rate quoted should be final and tenderer shall not be allowed to change the same under any circumstances and it should be valid for one year.
7. Certificate from District Collector/any Govt. / Semi Govt. organization etc. about past experience and performance of transportation in handling storage/transport work will be furnished along with the tender paper. Accepting authority shall have the right not to accept tender (s) of registered transport Contractors /Agents/Individuals who have not performed satisfactorily in the preceding years under Govt. of Odisha.
8. Earnest money of Rs.5, 00,000/- (Rupees Five Lakhs only) in shape of postal Savings pass book/ Bank passbook /NS.C. /Term Deposit duly pledged in favour of DSWO Bargarh shall be furnished along with the tender. The E.M.D. amount shall be refunded to the unsuccessful tenderers after finalization of tender process. The Earnest money deposit of successful tenderers will be converted in to security deposit which will be refunded after successful completion of the period of contract and audit of accounts.
9. No tenderer shall be allowed to withdraw his tender/ earnest money deposit until the tender is finalized. In case the successful tenderer refuses to undertake the transporting assignment after acceptance of his tender, earnest money deposited by him will be liable for forfeiture. The whole or part of the security deposit will be forfeited for irregular performance or breach of any terms and conditions of Agreement during the period of contract.
10. Tenderer should submit the recent Solvency Certificate of Rs.30,00,000 (Rupees Thirty Lakhs) only from the competent authority along with the tender paper failing which the tender will be liable for rejection.
11. Up to date GST clearance certificate shall be furnished along with the tender.
12. Valid Agent's License registered for common carries under Road Carriages Act.2007 & Road Carriages Rule 2011 the competent authority shall be furnished along with the tender.
13. Up to date Income tax clearance certificate, self-attested copy of Pan Card shall be furnished along with the Tender.

14. All the documents attached with the technical bid shall be checked according to the checklist attached to the tender paper. The committee shall verify the attested copies in presence of tenderer/his authorized representatives.
15. Minimum 4 (Four) nos. of Heavy Goods vehicle (Trucks) owned by the Tenderer with up-to-date documents (Xerox copies duly attested) shall be furnished along with the Tender.
16. The agent will be responsible for delivery of the stock at AWC Point on proper weightment. 20% test check will be made by the stock receiving officer and expenditure incurred to that effect will be borne by the Transporting Agent.
17. The transporting agent should carry a weighing machine and weight the stock at the delivery point in front of the SHG/Janch Committee/Mothers committee at AWC points.
18. If two or more tenderers quote same rate, the District Tender Committee will take decision through negotiation by inviting revised offer in sealed envelope, in presence of all the qualified tenderers of the Districts.
19. The detailed Tender Paper in original should be submitted.
20. The detailed tender paper should be returned with the tender duly signed by the tenderer as a token of acceptance of terms and conditions.
21. Payment shall be made against submission of bills on completion of delivery of stock as per order of the competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of stock to whom it is concerned as per the approved rates incorporated in the agreement. The D.S.W.O., Bargarh shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. No advance payment will be made. The transportation cost will be paid subject to availability of funds.
22. The successful tenderer shall have to execute an agreement with the Collector, Bargarh as per terms and conditions as specified in the agreement form at his own cost within 7 days of the intimation of acceptance of his tender.
23. The authority may terminate the contract for violation of terms of agreement or any other reason to be recorded in writing.
24. In case of violation of conditions of tender the Transporting Agent will be booked under I.P.C., Essential Commodities Act, Prevention of Food Adulteration Act, and Prevention of Black Marketing Act.

25. Registered transport Contractors /Agent/Individuals having adverse record will not be entertained.
26. The tender without earnest money deposit and other required documents shall be liable for rejection.
27. There shall be two stages of bidding -Technical & Financial. Interested tenderers must submit their technical bid in an envelope subscribed as "TENDER/QUOTATION FOR ENGAGEMENT OF TRANSPORTING AGENT/CONTRACTOR UNDER SNP PROGRAMME OF BARGARH DISTRICT FOR THE YEAR 2025-26. The financial bid must be submitted as separate envelope subscribed as 'FINANCIAL BID FOR ENGAGEMENT OF TRANSPORTING AGENT / CONTRACTOR UNDER SNP OF BARGARH DISTRICT FOR THE YEAR 2025-26. These two envelopes must be placed in a third bigger envelope subscribed as „TENDER BID FOR TRANSPORTATION CONTRACTOR UNDER SNP PROGRAMME OF BARGARH DISTRICT FOR THE YEAR 2025-26.
