The Bidders should specifically superscribe, “**TENDER FOR SUPPLY OF REFRESEMENT MATERIAL (FOOD) TO ODISHA BLOOD CENTER, DHH, BARGARH** ” on the top left corner of the outer envelope containing Bid.

The tender paper will be rejected if the bidder changes any clause or Annexure of the bid document downloaded from the website.

**TERMS & CONDITIONS FOR SUPPLY OF REFRESHMENT MATERIAL (FOOD) TO  
ODISHA BLOOD CENTER, DHH, BARGARH**

1. Sealed tenders will be received by dated. 08.9.2025 up to 4 P.M by CDM & PHO, Bargarh for the purchase of refreshment material (Food).
2. Any bids received after the due date & time will be rejected /returned unopened to the sender. The tender will be received through Regd.post/Courier Services/Speed Post only.
3. The sealed bids submitted by the bidders will be opened by the CDM & PHO, Bargarh in his office at 11 A.M on dt. 10.9.2025. The bidders or their duly authorized representatives are allowed to be present during the opening of the bids, if they so like.
4. The bidder should be a register firm under GST Act.
5. The quoted rates should be inclusive of all taxes except GST.
6. The delivery of the items should be made in the Blood Center, Old DHH, Bargarh in good conditions.
7. If any items supply by the bidder is not in good condition, the same items will be replaced by the bidder within 24 hours.
8. Any conditional bids will not be accepted.
9. No advance payment will be made against execution of orders.
10. The rate should be initially valid for one year from the date of finalization of the bids or till finalization of next tender.
11. Selection of items may be followed by selection of samples whenever necessary.
12. If any information/documents furnished by the bidder with the tender papers are found to be misleading or incorrect at any stage there tender will be cancelled.
13. The EMD amount will be refunded to the successful bidder after one year from the date of finalization of the bid without any interest.
14. The supplier should supply the items within 72 hours from the date of issue of the supply order. If the supplier is unable to supply the items in time, the EMD amount will be forfeited and the firms will not allow for participating in any tender published by the undersigned for 2 years.
15. The make/brand of the items must be mentioned in the bid.
16. The undersigned reserve the full right to accept in full or part or reject any or all tenders without assigning any reasons thereof.
