QUOTATION CALL NOTICE

Sealed quotations are invited from registered, experienced, and reputed consultants/architects possessing valid Income Tax and GST registration certificates for selection of a "**Consultant for preparation of Detailed Project Report (DPR), Providing Project Management Consulting Services & Supervision at stages for implementation of different Developmental Projects under Barpali NAC**". Eligible applicants must have prior experience in preparing plans, designs, detailed estimates, and rate analyses for projects. Interested consultants may apply to the undersigned for engagement in various development projects of BARPALI NAC through a two-cover bid system.

The first cover (Technical Bid) shall contain all relevant technical documents, while the second cover (Financial Bid) shall include the price quotation. Only the financial bids of technically qualified bidders will be opened after the evaluation of technical bids.

The bidder must have qualified architect and a registered member of the Council of Architecture. Additionally, the consultant must have prior experience in similar nature of projects and possess original CAD software for drawing preparation.

Eligible bidders must have annual turnover of not less than ₹2 crore in any one year within the last three financial years. Preference will be given to consultants who have previously provided similar services to various Urban Local Bodies under the Odisha State Government and produce completion certificate from the respective ULBs.

Tender documents can be obtained from the NAC office on payment of ₹6,000/- (Rupees Six Thousand) only (non-refundable) and Rs. ₹10,000/- (Ten Thousand) for EMD Cost in shape of M.R/D.D/B.C. The sealed quotations must be submitted from dt.12.11.2025 to 20.11.2025 up to 1.00 PM and the technical bid will be opened on same day at 4.00 PM in presence of the bidders or their authorised representatives.

Financial bid will be opened on dt.24.11.2025 at 11.00 AM in presence of the successful bidders who have qualified in Technical evaluation. The approved rate will be valid for 3 years and agreement will be made with the L1 bidder which will be valid for 3 years from the date of the agreement.


