

CORRIGENDUM


In continuation to the Guidelines issued vide Letter No. 30643, Dt.04.12.2023 & clarification on guideline issued vide letter No. 32841, Dt.30.12.2025 on implementation of **Mukhyamantri Kanya Bibaha Yojana (MKBY)** and in partial modification of the provisions contained therein, the amount earmarked for Implementing Agencies towards organisation and conduct of marriage ceremonies under MKBY has been revised **from Rs.6,000/- to Rs.15,000/- per beneficiary**. Consequently, the total financial assistance under MKBY is enhanced from Rs.51,000/- to Rs.60,000/- per beneficiary.

All other terms and conditions of the MKBY Guidelines shall remain unchanged.
