The Sub-Collector Padampur Cum Chairman R.M.C Padampur invites Quotation from interested and eligible vehicle owners / suppliers / authorized dealers for purchase of one (01) number second-hand 50-seater bus with detached seat( Except Driver seat ) not exceeding 8 (Eight ) years of age, to be purchased by RMC Padampur for use as a Mobile Skilling Unit for Paikmal Block under Bargarh District.

### 1. Details of the Vehicle

- Type of Vehicle: Bus (Second-Hand / Used)
- Length of Bus : 10 Meter Length
- Maximum Age of Vehicle: Up to 7 to 8 Years from date of first registration
- Fitness: Valid Fitness Certificate at the time of quotation and delivery
- Purpose: Mobile Skilling Unit
- Registration: As per Motor Vehicles Act and Government norms
- Seat should be detached ( Except Seat of Driver )

### 2. Earnest Money Deposit (EMD)

- Each quotation must be accompanied by an Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees ten thousand )only
- The EMD shall be submitted in the form of Demand Draft / Bank Draft drawn in favour of RMC Padampur, payable at Padampur.
- Quotations submitted without EMD shall be rejected outright.
- The EMD of unsuccessful bidders shall be refunded after finalization of the process.
- The EMD of the selected bidder shall be adjusted against the final payment or forfeited in case of withdrawal or failure to comply with the terms and conditions.

### 2. Eligibility of Bidders

- The bidder may be an individual owner, supplier, or authorized dealer.
- The vehicle should be free from all encumbrances, loans, and legal disputes.
- Valid ownership documents must be produced.

### 3. Documents to be Submitted


- Quotation mentioning offered price (inclusive of all applicable taxes and transfer charges).
- Copy of Registration Certificate (RC).
- Valid Fitness Certificate.
- Valid Insurance Certificate.
- Pollution Under Control (PUC) Certificate.
- Undertaking stating the vehicle is accident-free and legally transferable.

#### 4. Terms and Conditions

1. The quoted price shall be inclusive of all taxes, transfer charges, insurance, and delivery costs.
2. The vehicle must be in good running condition and suitable for conversion/use as a Mobile Skilling Unit.
3. Physical inspection of the vehicle will be carried out by a committee before final selection.
4. Payment shall be made only after successful inspection, approval, and transfer of ownership in favour of RMC Padampur.
5. The undersigned reserves the right to accept or reject any or all quotations without assigning any reason thereof.
6. Conditional or incomplete quotations shall be rejected.
7. The successful bidder after approval of quotation and all legal formalities should handover the vehicle with detached seat leaving driver's seat. No seat will be there in the bus except of driver while physical handing over of the bus.




